## Further notes:

Of course, you have the right to be informed at any time about the personal data we process concerning you and to have this data corrected or deleted. You can also inform us if you wish to restrict the processing of your data. Furthermore, you have the right to object to the further processing of your personal data at any time. You can send your objection informally to the Executive Board in writing.

You have the right to receive from us, upon request, the personal data we have stored about you in a structured, common and machine-readable format or that we transfer the data to another responsible party.

In the event that you consider that the use of your data has been unlawful, you have the right to complain to the competent supervisory authority in accordance with Art. 77 GDPR.
